Invitation for Bids for the **Construction of the Bridge over Jyamire Khola**

1. The Makawanpurgadhi Rural Municipality **has allocated funds** from towards the cost of **Construction of the Bridge over Jyamire Khola** and intends to apply part of the funds to cover eligible payments under the Contract **for Construction of the Bridge over Jyamire Khola (CIF No. MRM/NCB/02/2075-76)**. Bidding is open to all eligible as per Section V of bidding document..
2. Makawanpurgadhi Rural Municipality invites electronic bids from eligible bidders for the construction of Bridge over Jyamire Khola under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRS. 51.8 Million**
 - Minimum Work experience of similar size and nature: **2 nos.**
3. Eligible Bidders may obtain further information and inspect the Bidding Documents PPMO e-GP system www.bolpatra.gov.np/egp.
 4. A complete set of Bidding Documents can be downloaded from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document of NRs. 5000.00 in the Project's Rajaswa (revenue) account as specified below .

5. Pre-bid meeting shall be held at Makwanpurgadhi Rural Municipality, Makranchuli, Makwanpur at 2019/04/09 (2075/12/26) at 14:00.
6. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 on 2076/01/08 (2019/04/21). Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2076/01/08 (2019/04/21) **at 14:00** at the office of Makwanpurgadhi Rural Municipality, Makranchuli, Makwanpur. Bids must be valid for a period of 90 **days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid amounting to a minimum of **1,177,500.00**, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
