1. Makawanpurgadhi Rural Municipality, Makawanpur invites electronic bidding from eligible bidders for the Construction Work under the below mentioned Contracts under National Competitive Bidding procedures.
2. Bidding will be conducted through NCB in accordance with Single Stage Bidding Procedure.
3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Makawanpurgadhi Rural Municipality, Makranchuli, Makawanpur (www.makawanpurgadhimun.gov.np), info@makawanpurgadhimun.gov.np.
4. A complete set of Bidding Documents to be purchased from the office Makawanpurgadhi Rural Municipality Office of the Rural Executive, Makranchuli, Makawanpur by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, VAT Registration, Tax Clearance Certificate for the FY 2076/077 and upon payment of a non-refundable fee as mentioned in table given below till 26/06/2020 (2077/03/12).
5. Pre-bid meeting shall not be held.
6. Electronic bids must be submitted to the office "Makawanpurgadhi Rural Municipality, Makranchuli, Makawanpur" by hand on or before 12:00 noon on 28/06/2020 (2077/03/14). Bids received after this deadline will be rejected.
7. The bid will be opened in the presence of Bidders' representatives who choose to attend at 14:00 on 28/06/2020 (2077/03/14) at the office of "Makawanpurgadhi Rural Municipality, Makranchuli, Makawanpur". Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security, amounting to a minimum as mentioned in table below which shall be valid for 30 days beyond the validity period of the bid.
